## Changes for Tax Receipts

To All Participants,

Please note that due to recent changes the Canada Revenue Agency now requires full mailing addresses on all official tax receipts. The standard donation to trigger automatic receipts has also been increased to \$20. These changes are reflected on the pledge forms. Donations of \$20 or more without a full mailing address on the pledge form will not be eligible for a tax receipt.

If a donor wishes to have their tax receipt sent to them via email they will have to enter their full mailing address on the pledge form, enter a check mark in the box next to their address (column labelled "EMAIL REC?") AND enter their email address on the new (included) email address form. While it would be convenient, you are not required to match the row numbers from each form. If you do decide to match row numbers, only the email address has to be entered on the email form but you may have to print an email form for each pledge form

If your printer is capable of double sided printing, using this package the pledge form will print on one side of a page and the email form will print on the back. If you single sided printing and have donors who wish to receive their tax receipt via email, please include/attach the email form along with your pledge form(s).
